Important Note regarding Skill Test:

1. The post of Jr. Stenographer (H) falls against roster of 'Un-Reserved' category. Shri Amit Kumar Verma is an OBC candidate, at the time of filling of application his age was 25 years 1 month and 10 days and has availed age relaxation upto 28 years as permissible to OBC candidate at the time of filling of application for the above post. As per rule, only those candidates of reserved categories who come on merit without any relaxations like age, qualifications, experience etc. will be counted against unreserved vacancies. Hence, Shri Amit Kumar Verma is not eligible as he was over age at the time of application for the post of Jr. Stenographer (H) under UR category though he qualified the Skill Test. Shri Mayank Dwivedi the next candidate on the merit qualified the skill test and fulfills eligibility criteria for the said post, so he is eligible for the post of Jr. Stenographer (H).

2. Shri Varun Priyadarshi had applied as a Departmental candidate and taken age relaxation (upto 40 years) at the time of filling up the application for the post of LDC. The Committee constituted for document verification found that he is not a departmental candidate as he is working in one of the Institute of NCCT as contractual employee. The employees working in Government Organizations on contract basis not covered under the definition of Departmental Candidate. Though he qualified the Skill Test, he is not eligible for the post of LDC as he was overage at the time of application. So, no candidate was selected for the post of LDC.
